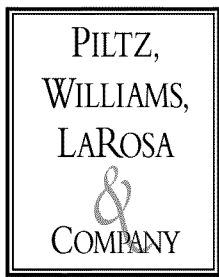

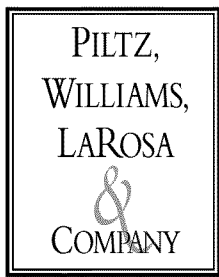

In FY 2017, United Way of South Mississippi addressed needs by providing multi-year program grants to 9 local nonprofit agencies carefully selected by volunteers who served on the Community Investments Team. United Way of South Mississippi supported our impact area through community impact grants, disaster grants, pass through distributions and funder's grants in FY 2017, totaling more than \$280,000 in distributions. Other impact initiatives are the FamilyWise prescription discount cards saving South Mississippians \$208,705 on prescription drugs and Volunteer Income Tax Assistance program returning \$4.2 million to our community through free tax preparation. We honor donor requests to designate contributions to any 501(c)(3) or 509(a).

United Way of South Mississippi worked to develop long-term solutions to address school readiness and reading on grade level by the end of the 3rd grade. Research shows that students who fail to master reading by the end of third grade are four times as likely to leave school without a diploma as proficient readers. Our goal is to invest in our most critical resource - our children and their families - in order to create a brighter future for South Mississippi. Our education initiatives helped children enter kindergarten more likely to succeed by working with parents and childcare providers to assess and support social and emotional growth. In 2017 we distributed 25,496 books through Dolly Parton's Imagination Library and trained a team of volunteers in developmental assets by sponsoring a United Way Readers

United Way of South Mississippi is a key resource in volunteer involvement in the community. The Volunteer South Mississippi Center maintains an online database that matches interested volunteers with projects in their community and organizes the annual Days of Caring volunteer event, in addition to hosting various webinars, a diaper drive, a fill the bus drive and volunteer opportunities for groups that visit South Mississippi. A total of 151,846 volunteer hours were documented with a total monetary impact of \$3.7 million.
