TERMS AND CONDITIONS**



All entrants understand and agree to the terms and conditions of the United Way of South Mississippi 2020 Nifty Fifty (\$50,000) raffle for the benefit of United Way of South Mississippi set forth herein:

1. An entry represents a chance to win the opportunity to accept an offer of the stated prize as per the terms and conditions set forth herein and in the Winner Notification Agreement. Sales begin at 12:01 a.m. CST. on Saturday, August 1, 2020. Important dates:

**Early Bird Sales Deadline:** September 25, 2020 at 11:59 p.m. CST

**Early Bird Drawing:** September 30, 2020

**Early Bird Drawing Location:** AVL in Gulfport, MS

**Grand Prize Sales Deadline (checks only):** October 23, 2020 at 11:59 p.m. CST

**Grand Prize Sales Deadline (cash/online/credit card only):** October 27, 2020 at 5:00 p.m. CST

**Grand Prize Drawing:** October 28, 2020

**Grand Prize Drawing Location:** Patio 44 Coastal Seafood & Steaks in Gulfport, MS

2. The purchase of a raffle entry constitutes full agreement by the purchaser to all terms and conditions set forth herein and in the Winner Notification Agreement.
3. No one will be eligible to win who procures an entry without valid payment of the purchase price either through a check returned for "insufficient funds", "closed account" or through charge to a debit or credit card that is "declined", "invalid", or "stolen".
4. Purchasers of entries must legibly write their name, address, phone number and email address (if applicable) on their application.
5. Entries may not be issued in the name of a company or business.
6. If more than one name is listed on the entry, the first name listed shall be considered the "entrant", unless the entry is in a Mr. & Mrs. format for a married couple. United Way of South Mississippi does not have an obligation for delivery of any prize to any person other than the entrant (an individual's name on an entry). The entrant is responsible for coordinating delivery efforts with groups that purchase an entry.
7. United Way of South Mississippi is not responsible for entries lost in the mail or otherwise not received by it.
8. A maximum of 1,500 entries will be sold. If less than 750 entries have been sold by 11:59 p.m. CST on Friday, October 23, 2020, the raffle will change from a \$50,000 payout to a 50/50 split of proceeds from sales received to date.
9. United Way of South Mississippi reserves the right to conduct additional drawings throughout the raffle. All additional raffle winners will remain eligible for the Nifty Fifty raffle to be held on Wednesday, October 28, 2020. Terms and conditions apply to additional drawings. The

winner need not be present at the drawings. Prizes outside of the grand prize drawing of \$50,000 must be claimed in person within 30 days of the date of the drawing. Otherwise, the prize will be considered forfeited by the entrant.

- a. An Early Bird drawing will be held internally by an independent accounting firm on Wednesday, September 30, 2020. Entries for this drawing must be purchased by 11:59 p.m. CST on Friday, September 25, 2020.
  - b. Remaining prizes will be drawn immediately before the Nifty Fifty Raffle on Wednesday, October 28<sup>th</sup>, 2020. The Nifty Fifty grand prize of \$50,000 will be held during the WLOX 6:30 p.m. CST news at Patio 44 Coastal Seafood & Steaks in Gulfport, MS.

After the raffle winner is selected on Wednesday, October 28, 2020, the United Way of South Mississippi will forward the winner a Winner Notification Agreement and Form 5754, to be sent via certified, return receipt U.S. Mail. The winner will have ten (10) calendar days from the date of the winner's receipt of the Winner Notification Agreement and Form 5754 to accept the cash (less applicable taxes) by executing and returning to United Way of South Mississippi the signed Winner Notification Agreement and Form 5754 pursuant to the terms and conditions stated therein. Upon receipt of the Winner Notification Agreement and Form 5754, the cash prize (less applicable taxes) will be tendered to the winner within thirty (30) calendar days from the date of the winner's acceptance of the cash prize as evidenced by execution of the Winner Notification Agreement. If the executed Winner Notification Agreement and Form 5754 are not received by United Way of South Mississippi within said period, the prize will be automatically forfeited by the drawing winner and all proceeds will go to the United Way of South Mississippi.

The winner of the United Way of South Mississippi Nifty Fifty (\$50,000) raffle is subject to any and all applicable federal, state and local taxes payable due to the winner's acceptance of the cash prize.
